GENERAL RECOMMENDATIONS

SEAWEED MAX is a unique combination of seaweed and humic acid specifically designed for use on turfgrasses.

Fine Turf Application

Apply 1.5 - 3 ounces per 1,000 sq. ft. or 2 - 4 quarts per acre per month during the growing season. Total minimum seasonal rates of 20 quarts per acre should be applied for highly stressed areas.

Fertigation

Inject into irrigation at 1.5 - 3 ounces per 1,000 sq. ft. or 1-2 gallons per acre 3-6 times during the growing season.

Deep Root Injections

Apply 2-4 quarts per 10 gallons of injection solution.

Optimum rates of application will vary between crops and fields, depending on soil and organic matter content. For best results, follow soil test or plant analysis recommendations.
